

2022-2023 FEE AND TUITION INFORMATION

Costs incurred by Holy Cross Lutheran School, including staff salaries, materials, crafts, study trips, student gifts and special events are off-set by enrollment fees, tuition, individual donations, fundraising and the congregation of Holy Cross Lutheran Church.

APPLICATION & ENROLLMENT FEES (non-refundable): An application fee of \$25 is due at the time of application (new students only.) An enrollment fee of \$150 for the Early Childhood Programs and \$200 for the Elementary/Middle School (Kdg - grade 8) is due annually at the time of enrollment or re-enrollment.

TUITION: Tuition is per student and varies dependent upon the program enrolled in. Tuition can be paid according to one of the three tuition schedules/payment plans outlined below. Please note that a non-refundable initial payment/deposit of 10% of the annual tuition is due on 5/1/2022, regardless of the payment plan chosen. The remainder of the tuition balance can be paid in one annual payment, two semester payments, or nine additional installments. All tuition and incidental expenses are paid through FACTS Management Company, and all families are required to establish a FACTS payment account. FACTS charges a small annual fee for their service which ranges from \$15 to \$40, dependent upon the payment plan chosen.

TECHNOLOGY FEE: A non-refundable Chromebook rental fee of \$100.00 per year is due on April 1, 2023 for students enrolling in 4th or 5th grade. A non-refundable Chromebook purchase fee of \$340.00 is due on April 1, 2023 for students enrolling in 6th grade, and new 7th & 8th grade students.

ADDITIONAL EXPENSES: All Elementary/Middle School Students will have a school supply list at the start of each school year. In addition, participation in optional programs including (but not limited to) Afternoon with the Arts, Sports Programs, overnight class trips (grades 5-8), Fun Lunch Friday, and Before and After School Care will incur additional fees. Participation in PTO fundraisers and Chapel Offerings are optional.

Tuition assistance based upon financial need is available. Holy Cross Lutheran School participates in the Indiana Choice Scholarship (Voucher) program and Tax Credit Scholarships (SGO). Holy Cross also offers their own tuition assistance program and has contracted with an organization called FACTS to provide a confidential, objective assessment of financial need.
